MEMORANDUM OF UNDERSTANDING

Between

This is an agreement between Arts and Commerce College, Nagthane Tal & Dist: Satara-415519 and Nagthane Agro Vision Producer Company Ltd., Nagthane Tal & Dist: Satara-415519 herein called 'Industry Partner'.

I. PURPOSE AND SCOPE:

The purpose of this MoU is to clearly identify the roles and responsibilities of each party as they relate to the implementation of the **Diploma in Food Processing of Ginger, Guava, Tomato, Turmeric, Sugarcane etc.** at Arts and Commerce College, Nagthane. Nagthane Agro Vision Producer Company Ltd., Nagthane is intended to help and provide service learning and other opportunities to Arts and Commerce College, Nagthane students through partnership. To support this goal, Arts and Commerce College, Nagthane and Industry Partner will work together to conduct service that meets needs of our communities.

Both Arts and Commerce College, Nagthane and Industry Partner should ensure that the programme activities are to be conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MoU is intended to establish clear guidelines regarding the service work that will be conducted at Arts and Commerce College, Nagthane and if required at the site of the Industry Partner.

Both parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

II. Background:

This Industry Partner will be the first for the course to provide service learning and other opportunities coordinated between Arts and Commerce College, Nagthane and **Nagthane Agro Vision Producer Company Ltd., Nagthane.**

III. ARTS AND COMMERCE COLLEGE, NAGTHANE RESPONSIBILITIES UNDER THIS MoU:

- To enroll the students.
- Collect the fees and funds from UGC and to utilize it.
- To verify hours completed by each Arts and Commerce College, Nagthane participant.
- To provide all the infrastructure facilities to the students.
- To prepare the detailed curriculum of the course in consultation with all the Industry Partners, Board of Studies (BoS) and Industry Association.
- To appoint the faculty and related staff.
- To carry out all other activities as per UGC rules and guidelines for the course.
- To give the credits and to evaluate the participants.
- To award the Diploma Certificate to the participants.
- Arts and Commerce College, Nagthane will make available students to Nagthane Agro Vision Producer Company Ltd., Nagthane each year for training as well as job.

IV. NAGTHANE AGRO VISION PRODUCER COMPANY LTD., NAGTHANE RESPONSIBILITIES UNDER THIS MoU:

Industry Partner shall undertake the following activities

- Provide any necessary training required.
- Provide technical knowledge for the equipment required to complete each part of the course and related project work.

- To guide for all supplies necessary to complete each project.
- Be in an attendance for any events coordinated through this partnership.
- Provide guidance and supervision to participants.
- To assist for an evaluation for each Arts and Commerce College, Nagthane participant.
- To help the participants for the placement.

V. FUNDING:

This MoU does not include the exchange of funds between the two parties. As per UGC rules the remuneration will be paid to the faculty/staff of the Industry Partner for teaching/practical/project work.

VI. RECORD RETENTION:

All records will be retained with Arts and Commerce College, Nagthane from the date of MoU.

VII. EFFECTIVE DATE AND SIGNATURE:



Arts and Commerce College, Nagthane and Nagthane Agro Vision Producer Company Ltd., Nagthane indicate agreement with this MoU by their signatures.


